



## Update on Services at the Consulate

Thank you for your patience during this particularly difficult time of COVID-19. While we understand your frustration with longer than normal waiting times for services, the Consulate still provides only limited in-person appointments. If you are unable to find an available time on our website, we encourage you to check back frequently as new slots are regularly added.

Minors and those completing the DS-11 form for their first adult passport can schedule an appointment online

Adult U.S. citizens using the form DS-82 to renew a previous passport can courier the application to the Consulate or use the new drop box to leave your completed application in a sealed envelope at the main gate of the Consulate.

## Virtual Town Hall Meeting

The Consulate will hold a virtual American Citizen Town Hall on February 27<sup>th</sup> at 10:00 a.m. The meeting will provide participants an opportunity to connect with Consulate officials and share priorities and concerns and to ask questions.

Participating in the one-hour event will be Consul General Joel Reifman, Consular Chief Clark Ledger, and a representative of the CDC office in New Delhi. Topics will include plans for the New Consulate Compound in Hyderabad, the U.S.-India relationship, and a discussion of the U.S. Government's latest actions and advice on COVID-19. Participants will have the chance to submit questions in advance or during the session. A registration link will be sent out through the Consulate's social media channels and to the STEP mailing list.

#### Holiday Trivia: Presidents' Day



The origin of Presidents' Day lies in the 1880s, when the birthday of Washington commander of the Continental Army during the American Revolution and the first president of the United States—was first celebrated as a federal holiday. In 1968 Congress passed the Uniform Monday Holiday Bill, which moved a number of federal holidays to Mondays. The change was designed to schedule certain holidays so that workers had a number of long weekends throughout the year.

During debate on the bill, it was proposed that Washington's Birthday be renamed Presidents' Day to honor the birthdays of both Washington (February 22) and Lincoln (February 12). Following much discussion, Congress rejected the name change.

After the bill went into effect in 1971, however, Presidents' Day became the commonly accepted name, due in part to retailers' use of that name to promote sales and the holiday's proximity to Lincoln's birthday. Presidents' Day is usually marked by public ceremonies in Washington, D.C., and throughout the country.



#### It's Tax Season!

What you need to know about filing your tax returns from outside the United States

If you are a U.S. citizen or resident alien, the rules for filing income, estate, and gift tax returns and paying estimated tax are generally the same whether you are in the United States or abroad. Your worldwide income is subject to U.S. income tax, regardless of where you reside.

#### When to File

If you are a <u>U.S.</u>
citizen or resident
alien residing overseas, or are
in the military on duty outside
the U.S., on the regular due
date of your return, you are
allowed an automatic 2-month
extension to file your return
without requesting an
extension. For a calendar year
return, the automatic 2-month
extension is to June 15. Note
that you must pay any tax due
by April 15 or interest will be
charged starting from April 15.

#### Where to File

If you are a U.S. citizen or resident alien (including a green card holder) and you live in a foreign country, mail your U.S. tax return to:

#### **Electronic Filing (e-file)**

Taxpayers with an AGI (Adjusted Gross Income) within a specified threshold can electronically file their tax return for free using Free File.

Taxpayers with an AGI greater than the specified threshold can use the Free File Fillable Forms, the e-file by purchasing commercial software, or the Authorized IRS e-file Provider Locator Service.

#### Latest Updates on Coronavirus Tax Relief


The Internal Revenue Service and the Treasury Department have started delivering a second round of Economic Impact Payments as part of the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 to millions of Americans who

received the first round of payments earlier this year.

No action is required by eligible individuals to receive this second payment. The IRS reminds taxpayers that the payments are automatic, and they should not contact their financial institutions or the IRS with payment timing questions.

As with the first round of payments, most recipients will receive these payments by direct deposit. For Social Security and other beneficiaries who received the first round of payments via Direct Express, they will receive this second payment the same way.

#### FAQs about the COVID-19 Vaccines

# Which lasts longer, immunity after gettiing COVID-19 or protection from a vaccine?

The protection someone gains from having an infection (called "natural immunity") varies depending on the disease, and it varies from person to person.

Because this virus is new, we don't know how long natural immunity might last. Current evidence suggests that getting the virus again (reinfection) is uncommon in the 90 days after the first infection with the virus that causes COVID-19.

We won't know how long immunity lasts after vaccination until we have more data on how well COVID-19 vaccines work in realworld conditions. Experts are working to learn more about both natural immunity and vaccine-induced immunity. CDC will keep the public informed as new evidence becomes available.

# What percentage of the population needs to get vaccinated to have heard immunity?

Experts do not yet know what percentage of people would need to get vaccinated to achieve herd immunity to COVID-19. Herd immunity means that enough people in a community are protected from getting a disease because they've already had the disease, or they've been vaccinated. Herd immunity makes it hard for the disease to spread from person to person, and it even protects those who cannot be

vaccinated, like newborns. The percentage of people who need to have protection in order to achieve herd immunity varies by disease. CDC and other experts are studying herd immunity and will provide more information as it is available.

## What are the ingredients in COVID-19 vaccines?

## IMPORTANT NOTICE:

#### COVID Testing Required for US Entry

Effective January 26, 2021, the Centers of Disease Control and Prevention (CDC) will require all air passengers entering the United States (including U.S. citizens and Legal Permanent Residents) to present negative COVID-19 test results taken within three calendar days of departure, or proof of recovery from the virus within the last 90 days. Airlines must confirm the negative result or proof of recovery for all passengers two years of age and over prior to boarding. Airlines must deny boarding of passengers who do not provide documentation of a negative test or recovery.
