Embalming is done in all Government run hospitals and selected private hospitals in Chennai's consular district. Mortuaries are available in all Government run hospitals and a few private hospitals in South India. Embalming is mandatory if the remains are to be shipped. The laws governing shipment of remains apply nationwide.

**Part V**. Profile of services available in the host country regarding preparation and shipment of remains:

Due to limited refrigerated storage facilities available at hospitals, prompt arrangements for transfer of the body to a funeral home are required.

#### 1. Maximum period before burial:

Embalmed remains may be held for an indefinite period if authorized by a physician or local health authorities. Depending on space in the mortuary and other factors, unclaimed remains may be held for only a short period, perhaps 72 hours. In other cases, unclaimed remains may be held one month up or more depending upon the nature of death. In the event attempts to locate next-of-kin have failed, the unclaimed remains may be disposed of in a manner deemed appropriate by the police. The remains may be handed over to a teaching medical institution or a hospital for the purpose of anatomical examination.

#### 2. Embalming:

Embalming facilities are available at all major cities in the consular district. Embalming should be carried out as soon as possible, preferably within 24 hours of death. Embalming in India involves injecting formalin into the jugular/femoral vein; the amount injected depends on the condition/weight of the remains and the cause of death.

#### 3. Cremation:

Local and national law permits cremation. Cremation is done according to local customs on pyres of firewood and cowdung cakes. Electric crematoria also exist in all major cities.

#### 4. Caskets and Containers:

Caskets and containers meet the requirements for shipment out of the country. They are constructed by professional undertakers.

#### 5. Exportation of remains:

The following certificates must accompany the remains when they are removed from one state to another:

- 1) Official death certificate;
- 2) Permission from the Police Commissioner or the District Magistrate.

The following certificates are required to ship ashes abroad:

- 1) Official death certificate;
- 2) Certificate from the crematory;

3) A sealing certificate issued by the undertaker.

The following certificates must be produced along with the customs shipping bill filed with the customs authorities for shipping remains abroad:

- 1) Official death certificate;
- 2) Permission from the Police Commissioner or District Magistrate;
- 3) Certificate of Embalming from the physician;
- 4) An affidavit from undertaker stating that the remains have been properly packed;
- 5) Consular Mortuary Certificate.

## 6) Costs:

All prices quoted below are estimated shipping costs only and may be subject to change.

- a) Local Burial: Fees include collection of remains, teak plywood coffin, masonry grave and administrative fees \$900 \$1200
- b) Cremation to include collection and disposition of ashes \$800 \$1300
- c) Cremation and shipment of ashes by air to U.S.

Estimated cost includes casket, use of a hearse, crematorium charges, container of ashes and undertaker fees. Air shipment charges for cremated ashes are not included; the cost is calculated as per airway bill and destination. \$1000 - \$1500

d) Embalming and shipment of remains by air to the U.S.

Price includes embalming, necessary packing cases (coffin box, inner zinc box and outer packing case) sealing, labor, legal documentation, local transportation and charges of the undertaker. \$3500 - \$4000

In addition to the cost indicated above, the following are the air shipment estimates for 100 kilos from Chennai to:

East Coast (New York) \$4000 West Coast (Los Angeles) \$5000

## 7. Exhumation:

Permission must be obtained from the local magistrate.

#### 8. Autopsies:

Autopsies are performed when death occurs as a result of an accident or when the cause of death is unknown. There is no waiver of autopsy available, even for religious objections, if the local authorities deem it necessary.

## 9. Remarks:

Occasionally, administrative delays in exportation may occur if local officials are not familiar with the process
